Hello Randy, Tim, and Amy,

I'm making an open records request, pursuant to statutes referencing Open Records: Wis. Stat. §§ 19.31–19.39, and in accordance with the open records law compliance guide found here <https://www.doj.state.wi.us/sites/default/files/office-open-government/Resources/PRL-GUIDE.pdf>.

Could you please provide me with records covering and related to building coaches developing comfort/capacity in leading professional learning for staff around **equity in education**, which were included (or will be included) in **equity topics** in coaching cycles and in workshops provided to WCSD staff. This topic was specifically mentioned in the WCSD Board Book 9/8/22 Curriculum Committee meeting agenda under item - VI. **DEI AUDIT RECOMMENDATIONS** – attachment "Curriculum Committee Copy of DEI Ad Hoc Recommendations", and was the third item listed.

The time frame of my request should cover June 1, 2021 to present.

Please include the following, but not limited to:

- Identification of organizations utilized to provide the below resources (contracted or non-contracted) surrounding the topic of "equity in education" and "equity topics."
- Lesson plans of building coaches
- Resources provided and utilized by building coaches
- Schedules of trainings/resources/topics to be discussed
- Hard copy
- Handouts
- Digital resources
- Worksheets
- Work books
- Video
- Reading lists
- Reading lists as further resources

Please include District wide efforts in the above mentioned areas.

\*\*Also, in addition to the board book topic identified above concerning district wide conduct, please also provide any specific individual building (ie, Waunakee 4k, Arboretum, Heritage, Prairie, Intermediate, Middle, and High School) efforts/training/materials engaged in by ANY school staff at each of those locations. An example would be efforts to provide professional development in the area of **equity in education**, and **equity topics** specifically occurring at an individual school building, independent/or in addition to district wide conduct, engagement, or efforts (same materials requested as listed above).

The district has always been open and sharing of information, and I thank you for that transparency, and have no doubt it will continue. I suspect the items listed above, district wide or specific to a certain buildings, would need to be approved by administration to be used in the above mentioned areas, so hopefully gathering them will not be a difficult task.
